Staff Recommendation:

Staff recommends approval for the purchase of the Software as a Service (SaaS) product TimeClock Plus by Data Management, Inc. (DMI) in the amount of \$43,596.93.

Background & Analysis:

In 2010, the District experienced tremendous gains in efficient and accurate time & attendance management through moving from a largely paper-based time & attendance tracking system to an automated software solution; TimePro by Commeg Systems. As the District's needs grow, a reevaluation of current processes was necessary. The timing of this reevaluation is, in part, tied to a necessary interface with the District's new accounting software, Incode. Following extensive review, it has been determined that the current TimePro software no longer adequately meets the needs of the District and will cause a hindrance in making continuous strides toward increased efficiency and productivity.

DMI, the creators of TimeClock Plus, is a recognized leader in time & attendance and employee labor management technology. TimeClock Plus has a significant presence in the education and municipality sectors and is quickly become a leading solution in public sector organizations. TimeClock Plus is best suited to meet the complex needs of managing employee time. Key features of TimeClock Plus are as follows:

- It offers an easy-to-use platform and streamlined appearance for administrators and end-users.
- The software is customizable and can meet the unique requirements of the District's varied employee population.
