**Consider Purchase of TimeClock Plus**

Director Munn and Manager Hall outlined the following benefits of transitioning from the District’s current payroll system, TimePro, to TimeClock Plus:

- TimeClock Plus is more intuitive and efficient.
- The data for TimeClock Plus is stored on the cloud, instead of on the District’s network, which will decrease the frequency of system maintenance.
- TimeClock Plus will interface with Incode.
- TimeClock Plus offers GPS-based mobile options.

Manager Hall confirmed with Commissioner Schyman that TimeClock Plus will be utilized by all employees (exempt and non-exempt). She also confirmed with Commissioner Slepicka that the pricing for TimeClock Plus includes both hardware and software.

The Committee moved to approve the purchase of the Software as a Service (SaaS) product TimeClock Plus, by Data Management, Inc. in the amount of \$43,596.93 to the full Board for approval.
