Staff Recommendation:

Staff recommends the approval of the Sportsman's Country Club Tree Removals base bid in the amount of \$20,150.00 and Alternates #1-5 for a total of \$30,420.00 from Lucas Landscaping and Design of Deerfield, IL.

Background & Analysis:

The project consists of the removal and stump grinding of 142 dead or diseased trees at Sportsman's Country Club.

Four contractors submitted a bid that is listed below:
