## Northbrook Park District

Cook County, Illinois

### General Information

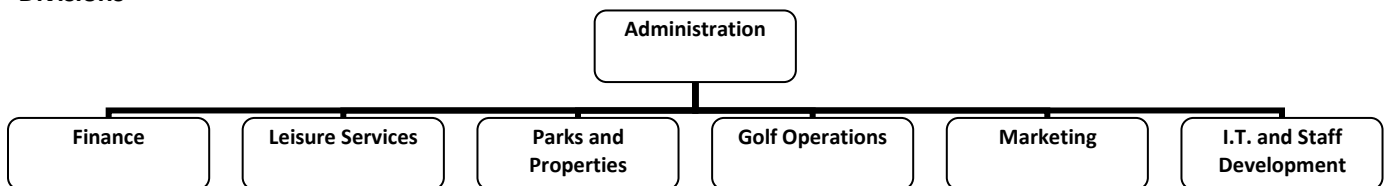
The Northbrook Park District, organized in 1927, is governed by a seven-member Board of Park Commissioners, elected on an at-large, non-partisan basis to serve a four-year term without compensation. The Commissioners elect officers, set policy and appoint an Executive Director responsible for the daily administration of the Park District. The District employs about 73 full-time staff and more than 700 part-time and seasonal staff. The Board of Commissioners established the following committees: Administration and Finance, Golf Operations, Leisure Services, Parks and Properties & Policy. The Board also appoints the Park District Attorney, Secretary, Assistant Secretary, Treasurer and Independent Auditors.

### Purpose

The Mission of the Northbrook Park District is to enhance our community by providing outstanding services, parks and facilities through environmental, social and financial stewardship. The Vision of the Northbrook Park District is to be recognized as a national leader in delivering innovative park and recreation services based on responsiveness, trust and accountability to our community. The District provides sports, cultural and leisure activities with a comprehensive year-round schedule of classes, programs, theatrical productions and special events designed to meet the recreational needs of all residents, from toddlers through senior adults, along with inclusion programs for residents with special needs. Programs are planned and reviewed annually.

### Facilities

The Northbrook Park District manages more than 500 acres of parks and five office facilities, listed below. The District offers an 18-hole and two 9-hole golf courses, a practice range, golf shop, miniature golf, two aquatic centers, two indoor and two outdoor ice rinks, two sled hills, two fishing lakes, a velodrome, skate park, Teams Challenge Course, the Trail Through Time, and the Dog Park. The District also provides soccer and lacrosse turf fields, outdoor tennis and volleyball courts, ball diamonds, soccer fields, basketball courts, football fields, walking trails and pathways, batting cages, picnic areas, cross-country skiing and 19 playgrounds. Indoor programs, including preschool, general recreation classes, the Northbrook Theatre and Senior Center, are housed at the Leisure Center. A map of parks and facilities is listed in the Northbrook Park District Recreation Guides, published four times each year, and on the website, [nbparks.org](http://nbparks.org).
