Staff Recommendation:

Staff recommends the approval of the base bid in the amount of \$46,986 from Illinois Pump, Inc. of Rolling Meadows, IL.

Background & Analysis:

The pump and motor for the blue waterslide has deteriorated creating instability on the platform where it is mounted. This pump/motor was identified for replacement in the *Existing Conditions* study in 2013/2014. The variable frequency drives that control the feature pumps are over ten years old and are approaching the end of useful life. Parks maintenance staff made multiple repairs so they would operate prior to opening. The feature pumps and motors at the Children's Pool need to be replaced in order to ensure proper operation for the extended pool season at the Meadowhill Aquatic Center. The pump and impeller for the Children's Pool filtration system failed at the end of the 2017 season and needs to be replaced.

Staff suggests approval of all four items as listed below: Item 1 – Open Body Slide Pump and Motor Replacement and Installation; Item 2 – Filtration Pump and Motor Replacement and Installation; Item 3 – Play Feature Pumps and Motors Replacement and Installation; and Item 4 – Variable Frequency Drives Replacement and Installation.

Staff Recommendation:

Staff recommends the approval of the base bid in the amount of \$10,000 for Meadowhill Park hockey rink, \$3,000 for Crestwood Park tennis courts and \$3,500 for Floral Park basketball court for a grand total of \$16,500 from 10-S Court Solutions of Lake Forest, IL.

Background & Analysis:

The National Intergovernmental Purchasing Alliance (National IPA) contracts are competitively solicited and publicly awarded by a government entity. National IPA competitively bids for products and services on a national level and meets Illinois State Procurement requirements.

The all-new GeoLink™ is the industry's turf-based precision spray system. Turf professionals benefit from substantial chemical savings thanks to individual nozzle control and the available sub-inch accuracy. It utilizes cellular Real Time Kinematic (RTK) correction technology to provide sub-inch accuracy. This sophisticated communication system receives location data from multiple satellites and a correction source to provide precise location information. By mapping out Sportsman's Country Club and Anetsberger Golf Course, precise applications can be made each and every time, year after year, regardless of who the operator is. Research done amongst local golf superintendents have shown savings from 23% on greens, and to as much as 11% on fairways.
