### **NEW BUSINESS-**

### **Consider Travel Expense Regulation Ordinance 17-0-1**

Director Munn explained that, in accordance with the Local Government Travel Expense Control Act, draft Ordinance 17-O-1 outlines the travel expense categories the District will reimburse for the Board and staff. She noted that the pricing established in the draft Ordinance is based on Chicago per diem rates, as listed on the General Services Administration website. The only exception to these rates is if the Board/staff stay at a hotel in which a conference is held.

Director Munn further explained that the Board will be required to complete and submit the Reimbursement Request Form (shown in Exhibit B of the draft Ordinance) to the full Board for approval for any District-related travel. Staff will need to complete and submit the Reimbursement Form to the full Board for approval only if the allotted amount(s) for travel is exceeded.

The consensus of the Committee was to approve Ordinance 17-O-1, regulating travel, meal and lodging expenses in accordance with the Local Government Travel Expense Control Act to the full Board for adoption.
