Re: Consent of Dual Representation

Robbins Schwartz has provided the District with the attached Consent of Dual Representation form to be discussed at our Board Meeting on Wednesday, October 25, 2017. If consensus agrees, this moves to an Action Item for approval.

The letter from Steven Adams and Heidi Katz spells out the conflict of interest with the firm of Robbins Schwartz representing both the Northbrook Park District and NSSRA as we pursue a joint capital development project at Techny Prairie Park and Fields. It is required both parties sign the Consent of Dual Representation before any consultation proceeds.

Re: Proposed Northbrook Park District /NSSRA Capital Development Project

Dear Molly and Craig:

You have informed us that the Northbrook Park District ("Park District") and Northern Suburban Special Recreation Association ("NSSRA") have agreed in concept to collaborate on the design and construction of a new Activity Center in Northbrook. The current concept for the Activity Center is to house park and recreational facilities and programs for the benefit of both agencies, and administrative offices for NSSRA, on real property owned by the Park District and commonly known as 180 N. Anets Drive, Northbrook, Illinois ("Project"). You have requested that our firm represent both parties in the preparation of an appropriate intergovernmental agreement, and the furnishing of legal services necessary to complete the Project.

This project presents our firm with a potential conflict of interest. Robbins Schwartz serves as general legal counsel to both the Park District and NSSRA.¹ It is incumbent upon our firm in this situation to disclose the conflict and review its implications with the Park District and NSSRA prior to commencing dual representation. That is the purpose of this letter.

Rules of professional conduct governing our practice hold that a lawyer may not represent a client in a matter if the representation of that client would be directly adverse to another client, unless the lawyer reasonably believes that the representation will not adversely affect the relationship with the other client, and each client consents after disclosure. For the reasons discussed next, we do not believe our representation of the Park District and NSSRA in the preparation of the intergovernmental agreement and the provision of subsequent legal services for the Project would adversely affect the interests of either party, or our relationship with other NSSRA client member agencies. Therefore, upon receipt of written consent from each party, we consider dual representation in this matter to be permissible.

Our representation of the Park District and NSSRA in preparing an intergovernmental agreement of the type under consideration would include the: (i) establishment of each party's legal authority

to enter the arrangement, (ii) reasonable allocation of design, construction, and property risks, rights, costs and responsibilities, and (iii) drafting of appropriate contractual provisions to protect each party's respective short- and long-term interests in the operation, use and enjoyment of the contemplated new facilities. Please note that, as a result of the dual representation, communications by either party with our firm regarding these matters will not be attorney-client privileged communications as between the parties.


If a dispute relating to the above matters were to arise between the Park District and NSSRA, we would be obliged to reconsider the continuation of dual representation under the applicable rules, and determine whether it is necessary to discontinue representation of either or both parties. We would consult with both the Park District and NSSRA prior to any decision to discontinue dual representation. Continued representation at that juncture would require us to review the ramifications of the particular conflicts involved, and obtain informed consent from both parties in order to proceed.

We will not proceed to represent either party in the preparation of the requested intergovernmental agreement, or any future work related to the Project until we have received written consent from both clients. Consent may be indicated by an authorized signature on the enclosed Consent to Dual Representation Form.
