NEW BUSINESS

Commissioner Slepicka said the paperwork for a 6B Property Tax Application by Pyramid Packaging, Inc. was discussed at the Village of Northbrook's Economic Development Committee last Wednesday. It appeared the school districts and Village were in favor of the request. After discussion among the Commissioners, they felt the criteria of a Cook County 6B request was not met. Executive Director Hamer will contact the Village of Northbrook on behalf of the District expressing that opinion.

INFORMATIONAL ITEMS / VERBAL UPDATE

Director Ziolkowski updated the Commissioners regarding interviews conducted to contract a communications firm for the District. Three firms were interviewed on April 6 and Jasculca Terman Strategic Communications (JTSC), Chicago, was selected. The scope of work includes developing a 3 to 5 year District Communication Plan that will involve input from staff, commissioners, stakeholders and residents. Director Ziolkowski and JTSC will also work with the Activity Center and Golf Course architects to craft key messaging on these two projects.
